Sir,

The National Small Industries Corporation (NSIC), is an ISO 9001:2015 certified Government of India Enterprise under the Ministry of Micro, Small and Medium Enterprises (MSME). NSIC has been working to promote, aid and foster the growth of MSMEs in India through its countrywide network of offices and Technical Centres.

We would like to inform that the Ministry of MSME issued the Guidelines of Capacity Building of First Time MSE Exporters (CBFTE) scheme vide OM No. 4(8)/2021-IC dated 15-07-2022. Copy of the scheme guidelines are enclosed for your ready reference.

The key interventions under the CBFTE scheme are as under:

Reimbursement of costs incurred by first time MSE exporters on export shipments:

- Registration-cum-Membership Certificate (RCMC) paid by the first-time exporters for registration with EPCs. (**To be implemented by EPCs**)
 - Export insurance premium paid by MSEs. (To be implemented by ECGC) ii.
- Fee paid on Testing & Quality Certification acquired by MSEs to export products. (To be implemented by NSIC)

Out of the above three sub-components, NSIC is the implementing agency for the third subcomponent only as highlighted above i.e. "reimbursement of Fee paid on Testing & Quality Certification acquired by MSEs to export products".

In this connection, we request you to disseminate the information about the said subcomponent of CBFTE scheme amongst the Micro & Small enterprises applying for export certification in your organization so that they may avail the benefit of the scheme.

In order to have further discussion in this regard, Ms. Mercy Epao, Joint Secretary (SME), Ministry of MSME and CMD, NSIC wishes to interact with all stakeholders and Export related Certification Bodies. The meeting is scheduled to be held online on 15th February 2023, Wednesday @ 4.00 PM.

Accordingly, you are requested to participate in the said virtual meeting or nominate concerned officer for participation.
