Spices Board has been informed that the Drawback & RoDTEP Committee headed by Shri. G K Pillai, will be visiting Kochi during 12-15th March, 2023 to visit some units in the marine sector. The committee (comprising of three members & two officials) has informed the Board about their intention to visit two spices processing units and to interact with representatives spice associations in the afternoon of 14th March 2023. Accordingly, a meeting has been scheduled from 3.00 to 3.30 pm on 14th March in the premises of M/s.Plant Lipids, considering the convenience of the committee and the availability of time.

In this connection, the associations of spices exporters (AISEF, ISFEA, IPSTA, FISS etc) are requested to co-ordinate among themselves and prepare inputs for discussion/presentation before the committee, on the requirements of the Indian spice sector.
