We are happy to inform you that Spices Board's regional Office, Navi Mumbai has planned to organise a Buyer Seller Meet for the spices exporters and the spices growers/suppliers of the Maharashtra state on 24th March 2023 at a suitable venue in Vashi, Navi Mumbai.

As you are aware, Maharashtra is producing various spices like turmeric, chilli, ginger, Chili, Kokum, Garlic, Cinnamon, Coriander, Black Pepper, Nutmeg and Tamarind, out of which turmeric production is huge with varieties of high curcumin cultivars. The state has also registered more than 20 Agriculture Geographical Indications (GI), of which five (5) are from spices sector and they are Kokam from Sindhudurg, Turmeric of Waigaon and Sangli (Rajapuri), Bhiwapur Chilli from Nagpur and Pomegranade of Solapur. All the Farmers Producer Organisations who registered GI tagged spices in the state will be participating in BSM.

Under the promotion of Agri Export Policy (AEP), the State government has announced three (3) clusters of spices like Chilli in Nandurbar, Buldhana and Nagpur Districts; Turmeric in Sangli, Satara, Hingoli, Washim, Wardha, Nanded, Yavatmal and Parbhani Districts; and Pomegranate in nine districts such as Sangli, Nashik, Solapur, Ahmednagar, Thane, Osmanabad, Washim, Buldhana and Latur. The state government also declared four districts for spices under One District and One Product (ODOP) and they are Hingoli, Wardha, Yavatmal and Nanded. Thus spices cultivation is getting momentum in Maharashtra and production is increasing every year.
